Our beef sales are still growing and are projected to grow further in 2019. We will give a full update at our annual meeting in the Dells on February 9th .

Wisconsin Grass-fed Beef Cooperative – 2018 Annual Business Meeting Minutes

Held at the Wintergreen Resort, Wisconsin Dells on Sat. Feb. 10, 2018; submitted by Tim Mathison

Introduction — Russ Endres, board president called the meeting to order at 9:45 a.m.

President Endres introduced the members of the Board of Directors and the Management Team. There were over 70 co-op members in attendance who introduced themselves.

Approve 2017 Annual Meeting Minutes – Greg Nowicki, Secretary provided the minutes from the 2017 Annual Meeting in a written newsletter sent to all members in January. Motion made and seconded to approve the minutes. MC

Treasurer's Report – Tim Mathison, the Co-op's accountant gave an overview of the 2017 financials. Co-op had profit of \$18,335 on sales of over \$1.6 million in 2017.

2017 Overview- Rod Ofte — General Manager, presented a summary and highlights of the first 10 years of the Co-op. These include, going from shipping 1—2 head per cycle to 15—20 head per week, and pushing toward \$2 million in annual sales. Also factoring in were the new branded van, our product launch in the greater Chicagoland area, the new 30# mixed box, and the improved tier pricing payments to producers.

2017 also had several challenges including lack of supply of consistent cattle, increasing competition, USDA and distributor challenges, multi destination processors, and lower than desired number of participants for leads, referrals, and demos.

The Board of Directors approved a Patronage Dividend for the 63 producers who shipped cattle to the Co-op in 2017. The total dividend is 30% of the net profit of \$18335, which is \$5500.55. The dividend checks were sent out in January and February 2018. Written copies of the 2017 P&L results were made available to all producers.

2018 Outlook and Business Approach – For 2018, the Co-op is looking to continue increasing the quality of cattle. Continued stable growth of 10% is forecast. Focus will be on growing our farm to table business and continuing our expansion into the Chicago markets. We will also be looking at a trial protein expansion into the pastured pork market.

Tiered Pricing Update – The importance of shipping properly finished cattle was reinforced because our customers pay a premium for high quality, consistent product. Low quality carcasses have less value to the Co-op and will be priced accordingly. Food businesses operate on paying different prices for different grades of product. The key to take away is if the producer doesn't know if the animal is

finished, they should not ship it. Effective February 1, 2018 producers will be paid on a five-tier pricing structure.

Awards – Pete Prochnow presented the Producer of the Year Award to Vince Hundt, and the Member of the Year Award to Bill and Laura Paine.

Annual Meeting Sponsors – Rod thanked Lorentz Meats, WI Farmers Union, Compeer Financial, and Great Lakes Alfalfa for sponsoring the annual meeting. Great Lakes Alfalfa gave a short presentation of their products in the afternoon session.

Board Member Nominations and Election Results –

Two seats were open for election. Kevin Moore chose not to run for another term. Nominees were current board member Gene Schreifer, past board member Mel Abel, and Brett Danke from Kolbe & Kolbe Farms. The results of the election had Gene Schreifer being re-elected and Brett Danke was the winner of the other seat.

Educational Session – A WGBC Producer Panel led a discussion on "Secrets to Successful Grass-fed Finishing". Members of the panel were Laura Paine, Vince Hundt, Greg Nowicki, and Jacob Marty. It was a great discussion with lots of questions from the producers in attendance.

Jim Munsch, a WGBC producer, gave a presentation entitled "Understanding the numbers: key financials to successful grass-fed beef operations".

Adjournment – The meeting was adjourned at 4:00 p.m. It was followed by happy hour and food prepared by Wintergreen Resort with our beef.

Pricing and Production Notes

New Wisconsin Meadows Pastured Pork: As our relationships have grown with existing customers, we have been asked if we could provide other types of local protein products over the years. We have done trials in veal and lamb previously but given that pork is a significant part of the protein offering in the U.S., local pork offerings are limited and about a third of our members currently raise pork, we conducted a small scale trial with a number of customers in 2018.

Our protocol is very simple and straightforward with no gimmicks. The pigs must be farrowed without crates and humanely treated (no ear notching or cutting of tails). They *can* be fed non-GMO corn, and maintain the natural omnivorous diet that hogs will pursue. They must also have plenty of space to roam and access to the outdoors and fresh water 24/7/365 just like our cattle.

Our current market price is \$1.50/lb hanging weight, and will probably go up slightly once the segment financials solidify. If you are interested in selling pork the cooperative, please contact Rod @ 608-451-2861.

Patronage Bonus change for 2019: Two years ago the WGBC board of directors voted to pay a Producer/Patron Bonus of 10¢ per pound hanging weight to those farms shippingmore than 12 animals

in the calendar year – that is, the 13th animal to unlimited – for that year. The objective was to encourage member farms with more production capacity to ramp up and also to reward loyalty to our cooperative.

The data collected to evaluate this action recently became available, and in response, your board moved to adjust the guidelines of the Producer/Patron Bonus – increasing the threshold to 16 head shipped in a calendar year. Additionally, cull cows will no longer be included in the "count" of animals shipped within the calendar year – so only fat animals (starting with the 17th) will receive the 10 cent bonus per pound.

We appreciate the tolerance and understanding of our members who market their animals with WGBC as we constantly strive to make the co-op profitable for all!
